1.Aims

This policy aims to show our commitment to meeting our obligations with regards to school attendance, including those laid out in the Department for Education's (DfE's) statutory guidance on [working together to improve school attendance \(applies from 19 August 2024\)](#), through our whole-school culture and ethos that values good attendance, including:

- Setting high expectations for the attendance and punctuality of all students
- Promoting good attendance and reducing absence, including persistent absence
- Reducing absence, including persistent and severe absence
- Ensuring every student has access to full-time education to which they are entitled
- Acting early to address patterns of absence
- Building strong relationships with families to make sure students have the support in place to attend school

We will also promote and support punctuality in attending lessons.

2. Legislation and guidance

This policy is based on the Department for Education's (DfE's) statutory guidance on [working together to improve school attendance \(applies from 19 August 2024\)](#) and [school attendance parental responsibility measures](#). 3.Roles and responsibilities

3.1 The local governing body

The local governing body is responsible for:

- Setting high expectations of all school leaders, staff, Students and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authority

- Making sure the school works effectively with local partners to help remove barriers to attendance, and keeps them informed regarding specific students, where appropriate
- Recognising and promoting the importance of school attendance across the school's policies and ethos
- Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for students who need it most by prioritising staff and resources
- Making sure the school has high aspirations for all students, but adapts processes and support to students' individual needs
- Regularly reviewing and challenging attendance data and helping school leaders focus improvement efforts on individual students or cohorts who need it most
- Working with school leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting students' needs
- Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - The school's legal requirements for keeping registers
 - The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific students, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data
- Holding the headteacher to account for the implementation of this policy
- Governor (Ellen Walkinshaw) to meet termly with the headteacher to review data and make sure there is a robust plan in place

3.2 The headteacher

The headteacher is responsible for:

- Implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual students
- Monitoring the impact of any implemented attendance strategies
 - Working with the parents of students with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for students with SEND, including where school transport is regularly being missed, and where students with SEND face in-school barriers
 - Communicating with the local authority when a student with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the student's needs

- Communicating the school's high expectations for attendance and punctuality regularly to students and parents through all available channels
- Issuing fixed-penalty notices, where necessary
- Sharing effective practice on attendance management via Headteacher Board and attendance leads.

3.3 The designated senior attendance leader responsible for attendance

The designated senior leader (also known as the 'senior attendance champion') is responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with students, parents/carers and external agencies, where needed
- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with Students and their parents/carers
- Delivering targeted intervention and support to students and families

The designated senior leader responsible for attendance is Michaela Knight and can be contacted via mkt@priorycofe.com

3.3 The attendance officer

The school attendance officer:

- Monitoring and analysing attendance data across the school and at an individual Student level
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports to school staff and reporting concerns about attendance to the designated senior leader responsible for attendance, and the headteacher
- Reports concerns about attendance to the school leader responsible
- Works with education welfare officers to tackle persistent absence
- Arranges calls with parents to discuss attendance issues
- Advises the headteacher when to issue fixed-penalty notices

3.4 Class teachers and form tutors

Class teachers and form tutors are responsible for recording attendance daily, using the correct codes, and submitting this information via EduLink.

3.5 School office staff / attendance team

These staff are expected to take calls from parents about absence and record it on the school system.

3.6 Parents

Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents are expected to:

- Make sure their child attends every day on time
- Call the school to report their child's absence before 8.45am on the day of the absence and each subsequent day of absence, and advise when they are expected to return
- Provide the school with more than 1 emergency contact number for their child
- Ensure that, where possible, appointments for their child are made outside of the school day
- Keep to any attendance contracts that they make with the school and/or local authority
- Seek support, where necessary, for maintaining good attendance, by contacting their Tutor or Head of Year, who can be contacted via 01306 887337 or their relevant email

3.7 Students

Students are expected to:

- Attend every timetabled session, on time

4. Recording attendance

4.1 Attendance register

We will keep an attendance register and place all students onto this register.

We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark, using the appropriate national attendance and absence codes from the School Attendance (Student Registration) (England) Regulations 2024, whether every Student is:

- Present
- Attending an approved off-site educational activity such as:
 1. Field trips and educational visits
 2. Sporting activities
 3. Link courses or approved education off site activities
 4. Most types of dual registration
- Absent
- Unable to attend due to exceptional circumstances

See appendix 1 for the DfE attendance codes. We will also record:

- Whether the absence is authorised or not
- The nature of the activity, where a student is attending an approved educational activity

- The nature of circumstances, where a student is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 6 years after the date on which the entry was made.

The school day starts at 8:55 AM and ends at 3:25 PM.

Students must arrive in school by 8:50 AM on each school day.

The register for the first session will be taken at 8: 58 AM and will be kept open until 9:30 AM. The register for the second session will be taken at 11:20 AM and will be kept open until 12:20 PM.

4.2 Unplanned absence

The student's parent/carer must notify the school the reason of an unplanned absence via EduLink or as soon as practically possible (see also section 7), by calling the student services staff who can be contacted via 01306 887337 option 5.

We will mark absence due to illness as authorised unless the school has a genuine concern about the authenticity of the illness. Where the absence is longer than 5 or if the student is a persistently absent student, or if the authenticity of the illness is in doubt, the school may ask the Student's parent/carer to provide medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied with the authenticity of the illness, the absence will be recorded as unauthorized, and parents/carers will be notified of this in advance.

4.3 Planned absence

Attending a medical or dental appointment will be counted as authorised if the student's parent/carer notifies the school in advance of the appointment by filling in the electronic absence request form.

We encourage parents/carers to make medical and dental appointments out of school hours where possible. Where this is not possible, the student should be out of school for the minimum amount of time necessary and return to school afterwards if possible. Evidence of the appointment may be requested.

The student's parent/carer must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

4.4 Lateness and punctuality

A Student who arrives late:

- Before the register has closed will be marked as late, using the appropriate code
- After the register has closed will be marked as absent, using the appropriate code

Please note that if students arrive at school after 8:55 AM a late mark will be recorded. If a child arrives after 8:55 AM they must sign in at the main office. If a child arrives after 9.30am they must report to Student Services, and it will be recorded as 'late after close of register' and counted as an unauthorized absence for the morning session.

4.5 Following up unexplained absence

Where any child we expect to attend school does not attend, or stops attending, the school will:

- Call the Student's parent on the morning of the first day of unexplained absence to ascertain the reason. If the school cannot reach any of the student's emergency contacts, the school may contact the police
- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained – this will be no later than 5 working days after the session(s) for which the student was absent

- Call the parent on each day that the absence continues without explanation, to make sure proper safeguarding action is taken where necessary. If absence continues, the school will consider involving an education welfare officer
- Where relevant, report the unexplained absence to the student's youth offending team officer
- Where appropriate, offer support to the student and/or their parents to improve attendance
- Identify whether the student needs support from wider partners, as quickly as possible, and make the necessary referrals
 - Where support is not appropriate, not successful, or not engaged with it will be escalated to Surrey Inclusion where a legal intervention will be considered.

4.6 Reporting to parents

Parents can keep up to date with their child's attendance using EduLink. They will also be informed of summative attendance as part of a student's written report.

5. Authorised and unauthorised absence

5.1 Approval for term-time absence

The headteacher will only grant a leave of absence to students during term time for certain educational activities, or to attend other schools or settings.

The headteacher will only grant a **leave of absence** to a student during term time if the request meets the specific circumstances set out in the [2024 school attendance regulations](#). These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave
- A temporary, time-limited part-time timetable
- Exceptional circumstances

A leave of absence is granted at the headteacher's discretion, including the length of time the student is authorised to be absent for. We define 'exceptional circumstances' as an event which could not be foreseen and there is no alternative.

Leave of absence will not be granted for a student to take part in protest activity during school hours.

As a leave of absence will only be granted in exceptional circumstances, it is unlikely a leave of absence will be granted for the purposes of a family holiday.

The school considers each application for term-time absence individually, considering the specific facts, circumstances and relevant background context behind the request.

Any request should be submitted as soon as it is anticipated and, where possible, at least 2 weeks before the absence, and in accordance with any leave of absence request form, accessible via the Attendance page on the school website. The headteacher may require evidence to support any request for leave of absence.

Other valid reasons for **authorised absence** include (but are not limited to):

- Illness (including mental-health illness) and medical/dental appointments (see sections 4.2 and 4.3 for more detail)

- Religious observance – where the day is exclusively set apart for religious observance by the religious body to which the student’s parent(s) belong(s). If necessary, the school will seek advice from the parent’s religious body to confirm whether the day is set apart
- Parent(s) travelling for occupational purposes – this covers Roma, English and Welsh gypsies, Irish and Scottish travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational purposes and has agreed this with the school, but it is not known whether the student is attending educational provision
- If the Student is currently suspended or excluded from school (and no alternative provision has been made)
- Other reasons the school may allow a student to be absent from the school site, which are not classified as absences, include (but are not limited to):
 - Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
 - Attending another school at which the student is also registered (dual registration)
 - Attending provision arranged by the local authority
 - Attending work experience
 - If there is any other unavoidable cause for the student not to attend school, such as disruption to travel caused by an emergency, a lack of access arrangements, or because the school premises are closed

5.2 Sanctions

Our school will make use of the full range of potential sanctions – including, but not limited to, those listed below – to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The headteacher (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the school issues a penalty notice, it will check with the local authority before doing so and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the school will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (10 sessions of unauthorised absence in a rolling period of 10 school weeks)
- Whether a penalty notice is the best available tool to improve attendance for that Student
- Whether further support, a notice to improve or another legal intervention would be a more appropriate solution
- Whether any obligations that the school has under the Equality Act 2010 make issuing a penalty notice inappropriate

A penalty notice may also be issued where parents allow their child to be present in a public place during school hours without reasonable justification, during the first 5 days of a suspension or exclusion (where the school has notified the parents that the Student must not be present in a public place on that day).

Each parent who is liable for the student's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a **first** penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same Student, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the school may offer a notice to improve to give parents a final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the student attends school.

They will include:

- Details of the Student's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under [section 7 of the Education Act 1996](#)
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

6.Strategies for promoting attendance

The Priory encourages regular attendance in the following ways:

- by providing a caring and welcoming learning environment
- by responding promptly to a child or parent's concerns about the school or other students
- by accurate and punctual completion of registers during morning and afternoon registration (see Punctuality and Lateness).
- by contacting parents if students are off with no reason identified

- by celebrating good attendance via tutors, assemblies, and certificates. We continue to investigate further methods to celebrate attendance in line with our rewards policy.
- The lead on Attendance will monitor students' attendance with the attendance team within school, Governors, the Home School Link Workers, the Inclusion Services and Learning Space.
- by informing parents/carers in writing of irregular attendance, including lateness,
- inviting parents/carers into school to discuss possible issues and how to support the students / family in raising attendance
- by if necessary, arranging meetings with parents/carers
- by if necessary, writing an attendance agreement between school, parents and students
- by referring the families to the attached Inclusion Officer if the irregular attendance continues

7. Supporting students who are absent or returning to school

7.1 Students absent due to complex barriers to attendance

We will work with families by:

- Student Services phoning regularly and signposting when the problem first occurs
- Heads of Years arranging a meeting to consider what the barriers are to attending and putting in an action plan to overcome these barriers
- Any referral to an outside agency completed if deemed relevant e.g. MHST, CSPA, Learning Space completed
- Inclusion lead, attendance lead or SENDCO to meet with family and to draw up an attendance agreement/contract.
- Any referral to alternative types of education completed e.g. use of Shore Centre, A2E, Student Support etc.
- Complete a referral to Surrey Inclusion if attendance contract does not improve attendance.

7.2 Students absent due to mental or physical ill health or SEND

- Meeting to take place with parents and student. Decide on a plan of action which could include:
 - Access to working in the Shore Centre
 - Referral to ELSA, MHST, HSLW, Learning Space, Mindworks, Student Support
 - Reduced timetable

Where a student has an education health and care (EHC) plan and their attendance falls, or the school becomes aware of barriers to attendance that related to the student's needs, the school will inform the local authority.

7.3 Students returning to school after a lengthy or unavoidable period of absence

- Meeting to take place with parents and student. Decide on a plan of action which could include:
 - Access to working in the Shore Centre
 - Referral to ELSA, MHST, HSLW, Learning Space, Student Support
 - Reduced timetable

8.Attendance monitoring

8.1 Monitoring attendance

Our school monitors attendance data

- Weekly looking for patterns of change of an individual student
- Weekly comparing the school's data to national data (FFT) including year data, gender, SEND and FSM6
- Half termly specifically looking at movement out of PA or SA
- Information given to tutors about who to specifically encourage to improve so they don't fall into PA.

The school will monitor attendance and absence data (including punctuality) half-termly, termly and yearly across the school and at an individual Student, year group and cohort level.

Specific Student information will be shared with the DfE on request.

The school has granted the DfE and FFT access to its management information system so the data can be accessed regularly and securely. Data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics.

The school will benchmark its attendance data at whole school, year group and cohort level against local, regional, and national levels to identify areas of focus for improvement and share this with the governing board.

8.2 Analysing attendance

The school will:

- Analyse attendance and absence data regularly to identify students, groups or cohorts that need additional support with their attendance, and
- Identify students whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence
- Conduct thorough analysis of half-termly, termly, and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns

8.3 Using data to improve attendance

The school will:

- Develop targeted actions to address patterns of absence (of all severities) of individual students, groups or cohorts that it has identified via data analysis
- Provide targeted support to the students it has identified whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severed absence, and their families (see section 8.4 below)
- Provide regular attendance reports to tutors and heads of years to facilitate discussions with students and families, and to the governing board and school leaders (including special educational needs co-ordinator, inclusion lead and SLT)
- Use data to monitor and evaluate the impact of any interventions put in place to modify them and inform future strategies

- Share information and work collaboratively with other schools in the area, local authorities and other partners where a student's absence is at risk of becoming persistent or severe, including keeping them informed regarding specific students, where appropriate.

8.4 Reducing persistent and severe absence

Persistent absence is where a student misses 10% or more of school, and severe absence is where a student misses 50% or more of school. Reducing persistent and severe absence is central to the school's strategy for improving attendance.

The school will:

- Use attendance data to find patterns and trends of persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Discuss with the student what they see the barriers to attendance are to see if they could be addressed
- Hold regular meetings with the parents of students who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - Discuss attendance and engagement at school
 - Listen, and understand barriers to attendance
 - Explain the help that is available
 - Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant
- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these students. In doing so, the school will sensitively consider some of the reasons for absence
- Send letters asking for medical evidence when any further absences occur
- Fine any unauthorised holiday
- Implement sanctions, where necessary (see section 5.2, above)

9. Changing School

It is important that if families decide to send the child in their care to a different school that they inform the school in writing immediately. A Student will not be removed from the school roll until the following information has been received,

- the dates the student will be leaving this school and starting the next
- the address of the new school
- notification from the new school that the student has started there
- the new home address if it is known

School staff will then confirm with the parents the leaving date for their child. Following this date, the student's school records will be sent on to the new school as soon as possible and within ten days of the child leaving. The Student Tracking Office at County Hall will also be sent appropriate information within ten days of anyone leaving or joining the school. If no notification is received from a new school, then the child's name will not be removed from the school roll until after an investigation by the Inclusion Service.

10. Monitoring arrangements

This policy will be reviewed as guidance from the local authority and/or DfE is updated, and as a minimum three years by Hannah Taylor (Attendance Lead). At every review, the template policy will be approved by the CEO and the school specific policy by the Headteacher.
